**MEMBERSHIP:**

**BOARD OF TRUSTEES:**

- 1) The Board of Trustees is Permanent.
- 2) Board of Trustee is having authorized and authentic power to elect the Managing Trustees, Secretary, and a Treasurer. And also administrative posts of the Trust.

**CESSATION OF TRUSTEE MEMBERSHIP.**

\* Any of the trustees may retire from the trust after giving two calendar months notice in writing of his or her intention to do so to Board of Trustees for the time being and upon the determination of such two months the trustee giving notice shall ipso facto cease to be the trustee of the trust.

**MEETING OF THE BOARD OF TRUSTEES:**

- A) The Board of Trustees shall ordinarily meet once in two months to conduct the business of the trust Such meeting shall be called ordinarily of the Board of Trustees by giving 14 days clear Notice before the date fixed for meeting and notice shall state place time and date accompanied with agenda
- B) Special emergent meeting of the Board of Trustees may also be convened by the managing trustees or the requisition of not less than 1/3 ( one third) of the trust

- C) The quorum for all the meeting shall be 50% , if meeting is adjourned for want of quorum then the trustees for meeting will hold meeting after half an hour at same place and transact the business for which it is called.

- E) The Board of trustees shall cause the minutes of its Annual/ Ordinary/ Special meeting to be dully recorded in a separate book special kept for each of such meeting.

#### PRIVILEGES POWERS AND FUNCTION OF BOARD OF TRUSTEES:

- A) To appoint Governing bodies to each of the educational institution (s) as required by the University or the Government.
- B) To appoint secretary and other employees required for the proper administration of the institution established by the trust.
- C) To invest individual funds and properties for the achieving of the objects of the trust.
- D) To keep deposits in the banks
- E) To purchase or take on lease or by any suitable arrangement donation, bequests, gifts etc, obtain land, building from whosoever concerned including from all or any of the trustees or other donors, to construct building upon land, to improve the buildings of the trust.

- I) To change or convert the existing property into any form or forms and in particular to sell moveable/immovable properties of the trust and to grant or to take on lease to exchange or transfer or any of the properties, to borrow money on the security of the trust properties or otherwise for the purposes of the trust.
- J) To do all other acts as may be absolutely required for the proper conduct of the trust, or for proper administration and management of the trust properties.
- K) The trustees cause to be maintained regular account of receipts and payments of the trust. It shall be lawful for the Board of Trustees from time to time frame such rules and regulations for the management and administration of the trust its educational Institutions/ Organizations, charities as deemed fit and to alter or vary the same from time to time and to make new rules and regulations .

Provided that none of the powers shall be so interpreted as to authorize the trustees to contravene or infringe any of the provisions contained in sections 2(15), 11 to 13 and section 80 G of the Income Tax Act 1961 as amended from time to time or any other law which may come into force in its place.

#### ANNUAL GENERAL MEETING:

1. There shall be a Annual General meeting of member of the trust once in a year. The notice of such general meeting shall be given to trustees 14 days before the date fixed for the meeting.

2. The main agenda for Annual General Meeting shall be"

A) To receive, consider and adopt the report of the Board of Trustees and audited statements of accounts of the trust.

B) The appointment of auditors, secretary, other official and to fix their remunerations, Consideration of any other subject proposed by the Board of Trustees.
